Tom Stodulka graduated in law at Sydney University in 1974 and has specialised in mediation for over 28 years, having mediated over 5000 disputes throughout Australia ranging from workplace, restorative justice and historic abuse matters, family and estate law, multi-million-dollar commercial transactions, franchise disputes, and multi-party disputes involving remote indigenous communities.

Tom was the founder of the Queensland ADR Forum. He is an FDRP, has national accreditation in multiple countries. He is a coach and an assessor at several universities, the Australian College of Law, and the Resolution Institute. He mentors and supervises new and experienced mediators.

Tom is a member of the Australian Mediation Association, Northern Mediators, the Conflict Resolution Centre and a Director of the Australasian Dispute Resolution Centre.

In 2017 and 2019, he was nominated for the National Mediator of the Year Awards. He is a Fellow of Bond University and was awarded the Resolution Institute 2019 Mediator of the Year (Australasian Law Awards). In 2020, he was awarded Facilitator of the Year in the national ADR Awards.
